LIABILITY & WAIVER RELEASE

WARNING..READ CAREFULLY. THIS AGREEMENT INCLUDES A RELEASE OF LIABILITY AND WAIVER OF LEGAL RIGHTS AND DEPRIVES YOU OF THE RIGHT TO SUE FOR PAWS UNLEASHED AND RELATED PARTIES. DO NOT SIGN THIS AGREEMENT UNLESS YOU HAVE READ IT IN ITS ENTIRETY. SEEK THE ADVICE OF LEGAL COUNSEL IF YOU ARE UNSURE OF ITS EFFECT.

FOR PAWS UNLEASHED POLICIES, PROCEDURES AND PET/GUEST RELEASE, WAIVER OF LIABILITY, ASSUMPTIONS OF RISK AND INDEMNIFICATION AGREEMENT.

In consideration for my pet being permitted to attend For Paws Unleashed (herein after "For Paws Unleashed" or "FPU") for day and overnight boarding (herein after "guest" or "pet") I make the following representations and agree to all of the following policies, procedures, terms and conditions:

1. **PET/GUEST REQUIRMENTS.** My pet meets the following guest requirements he/she: has successfully completed the behavioral evaluation/interview; is (4) months of age or greater; he/she is spayed or neutered (if over six (6) months of age) if not spayed or neutered I have informed the staff on the application; is current on his/her Rabies, Distemper and Bordetella vaccinations; is in good general health and free of ticks and fleas; is not aggressive or protective of toys; meets all other municipal or state licensure and other requirements; is attending For Paws Unleashed with a quick release collar that contains an identification tag bearing my pet's name and parent/owner's current contact information. I have completed the application and have provided For Paws Unleashed with a current and valid credit card number. My pet will enter and exit For Paws Unleashed with a leash.
2. **PET FOOD.** I understand that my pet will not be fed lunch. If I want my pet to eat lunch, I must bring a container marked with my pet's name and feeding instructions. For Paws Unleashed will provide overnight guest with food in accordance with the instructions provided by parents/owners or by what is listed on the application. All pets who are eating will be kept separate from all other pets.
3. **WEB CAM, PHOTOS AND VIDEO RELEASE.** I agree to allow For Paws Unleashed, LLC, it's owners, employees, or anyone affiliated with For Paws to use my pet's name and any images or likeness of my pet taken while he/she is a guest at For Paws Unleashed, in any form or format, for use, at any time, in any media, marketing, advertising, illustration, trade or promotional materials. I agree that this provision shall be binding on me and all of my successors, heirs, legal representatives and assigns.
4. **PERSONAL PROPERTY.** I agree that FPU shall not be responsible or liable for any lost, stolen or damaged personal property belonging either to me or my pet. I also understand and agree that my pet's collar may be removed in the play area to prevent injury to any dog. If my pet causes any damage to FPU facilities or equipment, I agree to be fully responsible for the full cost of any repair or placement.
5. **PET FEES.** I agree to pay for all fees, services and products with the credit card number I have provided in the application, or by cash or check at the time I pick up my pet after each visit to FPU. I give my express permission to FPU to charge any of my credit card numbers I provided on the application for any unpaid fees, services or products. I further agree to pay the cost of any check or debit charges returned or challenges for to any reason.
6. **LATE FEES AND CHARGES.** I understand that check out time for a boarded/daycare/grooming pets is by closing time of business hours (Monday-Friday by 6p/Saturday by 5p/Sunday only between 4p-6p). If I do not pick up my pet by business closing hours my pet will be boarded over night and I will be charged one nights boarding at full price and for each day after that my pet is boarded without a reservation.
7. **CANCELLATION POLICY.** I understand when making reservations for boarding and spa services I must make them with a credit card to guarantee accommodations/services. Boarding and Salon reservations must be cancelled 24 hours in advance or a one night accommodation charge or 50% of salon services will be applied to credit card.
8. **REFUNDS.** FPU's refund policy is available upon request.
9. **AGGRESSIVE DOGS.** My pet is not aggressive. Although For Paws Unleashed loves all dogs, I understand that aggressive dogs are not permitted to attend and services provided by FPU. If my pet acts aggressively or exhibits unacceptable behavior he/ she may be separated from the other guests. For Paws Unleashed will make reasonable efforts to consult our guests parents about aggression and ways to address it, however aggressive dogs may be asked not to return to For Paws Unleashed. Such determination will be made at the sole discretion of FPU.
10. **ABANDONED DOGS.** For Paws Unleashed is a place where all dogs are loved and can romp and play. No guest may be abandoned at FPU. I agree that I will not neglect to pick up my pet from FPU by the time he/ she is scheduled to leave without providing notification. Any guest that is left at FPU without any contact, instructions or notification from me, of the ability, willingness or plans to pick him/ her up by myself or my personal representative or agent, will be considered abandoned upon the seventh day of such notification failure. I understand that if I abandon my Pet at For Paws Unleashed, FPU will, by default, become the legal owner and guardian of the pet. FPU will, in its sole discretion, determine whether to try to re-home and adopt the pet from the For Paws Unleashed location at which he/ she was abandoned or will relinquish the pet to an unrelated shelter of choice. I FULLY UNDERSTAND AND AGREE THAT IF I ABANDON MY PET AT FOR PAWS UNLEASHED, I MAY BE UNABLE TO RETRIEVE POSSESSION OF MY PET AND WILL HAVE NO RECOURSE AGAINST FPU AS PROVIDED FOR BELOW.
11. **DUTY DISCLOSURE.** I have disclosed any and all medical or other conditions, including but not limited to personality concerns or behaviors that may affect, limit or prevent my pet's ability to participate in the services provided by For Paws Unleashed.

12. DAY CARE PARTICIPATION. I understand that day care participation in play time is at sole discretion of FPU and that guest may be separated from other guests or asked to leave for any reason in the sole discretion of FPU.
13. ACCEPTANCE AND ACKNOWLEDGEMENT OF FOR PAWS UNLEASHED PARTICIPATION RISK. I fully understand that: (a) there are inherent and potential risks involved with interactions between humans and dogs, as well as between dogs and other dogs, which may result in property damage or bodily injury, including permanent disability, sickness or death to human or dog; and (b) there may be other risks not know to me nor readily foreseeable at this time (collectively, "risks"). I fully accept and assume all risks and responsibility for all risks, including, without limitation, all losses, costs and damages incurred as a result of my or my pet's participation in the event.
14. VETERNIARIAN LIABILTY AND CARE. I agree to allow FPU to obtain medical treatment for my pet, if, in its sole discretion it appears that he/ she is ill, injured or exhibits any other behavior that would reasonably suggest that my pet may need medical treatment. I agree that I am fully responsible for the cost of any such medical treatment, and for the cost of any transportation for the purposes of such treatment, provided to my pet.
15. WAIVER, RELEASE AND INDEMNIFICATION. I HEREBY EXPRESLY AND FOREVER GENERALLY WAIVE, DISCHARGE CLAIMS, INDEMNIFY, RELEASE FROM LIABILITY, SAVE, HOLD HARMLESS AND DEFEND AND COVENANT NOT TO USE FPU, and their invitees, sponsors, advertisers, owners, officers, directors, employees, volunteers, invitees, agents, leasers, and any parties owning, controlling or having any interest in the property at which the Event is taking place, and all other representatives or agents (the "Releases") from and against ANY AND ALL INJURY, LIABILITY, CLAIMS, LITIGATION, ACTIONS, SUITS, COSTS, LOSSES relating in any way to (i) any act or omission of the Releases, including negligence, and (ii) my or my pet's participation in services/activities at For Paws Unleashed, or otherwise. I FUTHER AGREE TO INDEMNIFY, SAVE AND HOLD HARMLESS the Releasees from any claims, litigation, actions, suits, damages, costs, attorney's fees, losses or injuries as the result of any such claim. I AGREE THAT THIS RELEASE SHALL BE BINDING ON ME AND MY SUCCESSORS, HEIRS, LEGAL REPRESENTATIVES AND ASSIGNS. I ALSO EXPRESSLY AND FOREVER RELEASE FPU FROM ANY DUTY TO PROTECT ME OR MY PET(S) FROM INJURY OF ANY KIND, AND AGREE THAT EVEN IF FPU CHOOSE TO IMPLEMENT SAFETY PRECAUTIONS, SUCH ACTIONS SHALL NOT ALTER THE FACT THAT I HAVE RELEASED FPU FROM ANY DUTY TO PROTECT ME OR MY PET(S).

I HAVE READ AND FULLY UNDERSTAND THE TERMS OF THIS "FOR PAWS UNLEASHED POLICIES, PROCEDURES AND PET/GUEST RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT" (THE "AGREEMENT") AND UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OR ALL LIABILITY TO THE GREATEST EXTENT PERMITTED BY LAW AND AGREE THAT IF ANY PROTION OF THIS AGREEMENT IS HELD TO BE INVALID OR UNENFORCEABLE, THAT THE REMAINDER OF THIS AGREEMENT SHALL REMAIN IN THE FULL FORCE AND EFFECT. I AGREE THAT IT IS INTENDED THAT ALL TERMS OF THIS AGREEMENT CONTROL DESPITE AND PARTICULAR STATUTE OR LAW THAT WOULD OTHERWISE PROTECT ME OR MY PET(S).
